


The Value of Membership



Since the days of its first meeting in the 1970s, the North Carolina Polygraph Association has striven to provide an invaluable network of continuing education and resources to all its members

across the state. Today, with more than 75 members from both the law enforcement and private sector, the NCPA hosts two training sessions each year.

There is also a third training conference, typically in the summer, in which the NCPA in coordination with the Georgia Polygraph Association (GPA) and the South Carolina Association of Polygraph Examiners (SCAPE) hosts a Tri-State Training Conference in each state on a rotating basis. By combining resources with these other associations, we are able to provide additional high quality instruction and networking opportunities for our members on an annual basis.

Each of these training opportunities meet the continuing education requirements of North Carolina Private Protective Services for North Carolina licensed private polygraph examiners.

Our Objectives

1. To establish, maintain, and encourage the professional qualifications and ethical standards for polygraph examiners.
2. To provide polygraph examiners an opportunity to exchange information relative to the polygraph profession and to encourage such exchanges among polygraph examiners.
3. To encourage and support research, education, and training to promote a better understanding of the polygraph and its use.
4. To promote the advancement and improvement of the polygraph profession within the State of North Carolina.
5. To regulate the conduct of its members by encouraging the utilization of recognized and accepted standards of procedures and techniques to promote total professionalism.




Membership Dues

There are five (5) classes of membership: Member, Affiliate, Honorary, Life and Corporate.

The NCPA strives to make membership and training accessible and affordable to all polygraph examiners. Membership dues are \$50 annually. This covers the registration fee for the two training sessions (spring and fall) each year. The fee for non-members is \$100 per training session, making the \$50 membership fee a real value, which encourages membership and enhances our ability to provide quality training.
